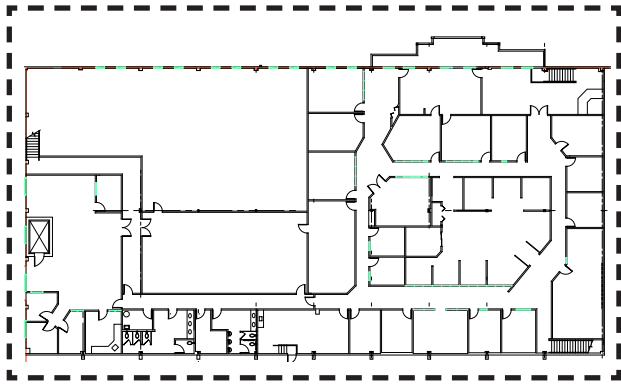

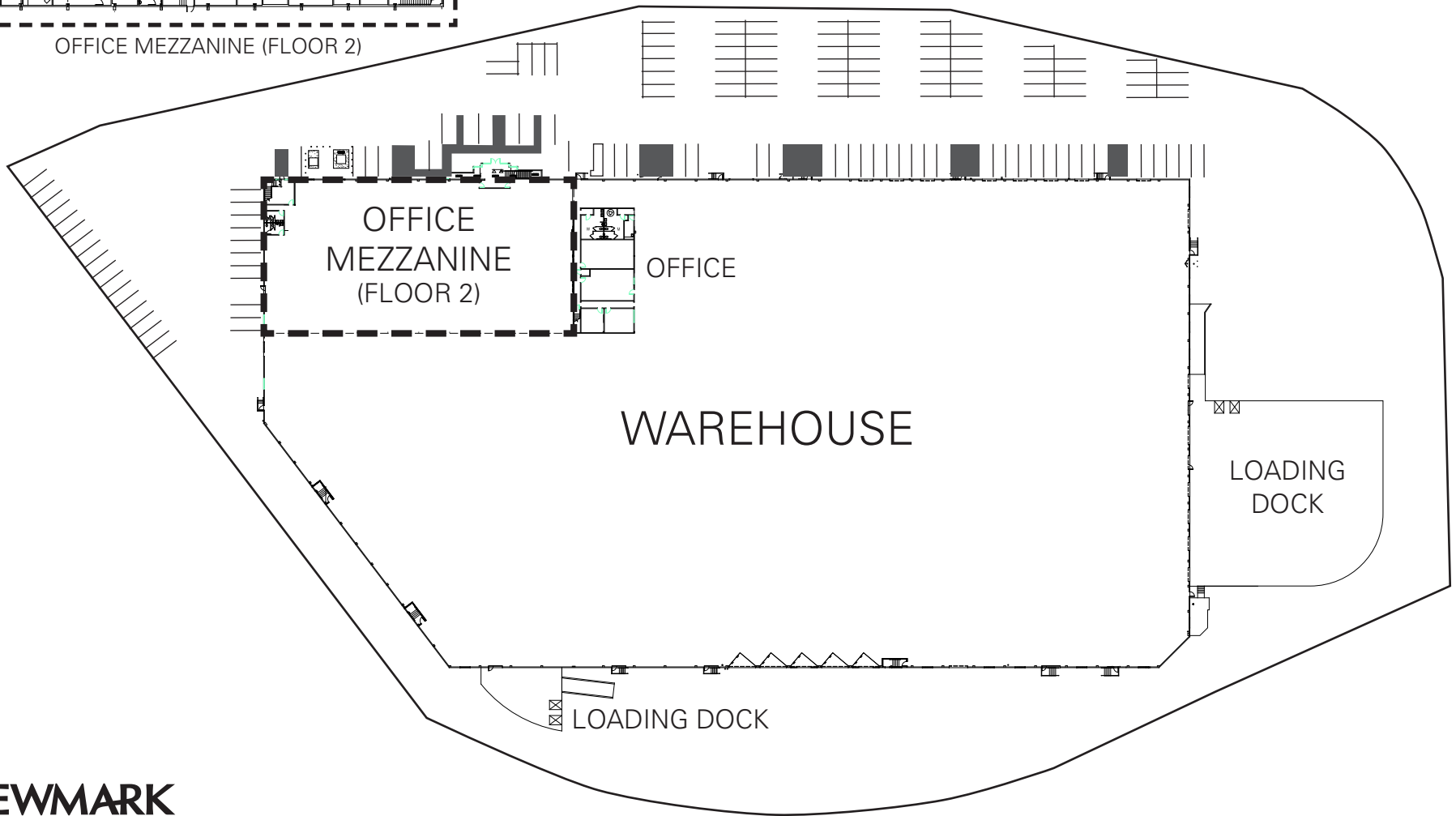

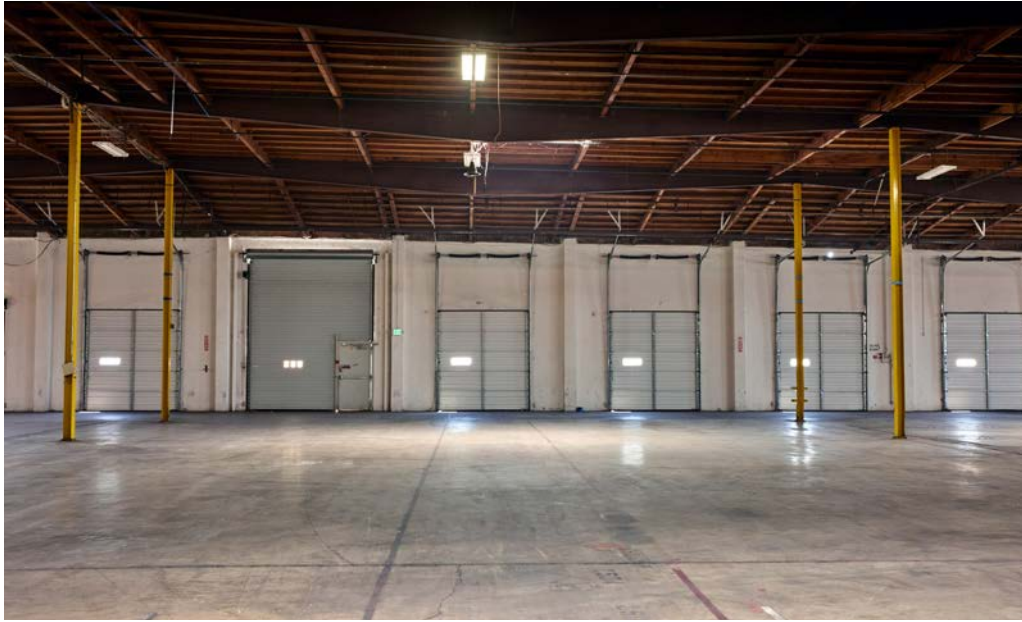

OFFICE MEZZANINE (FLOOR 2)

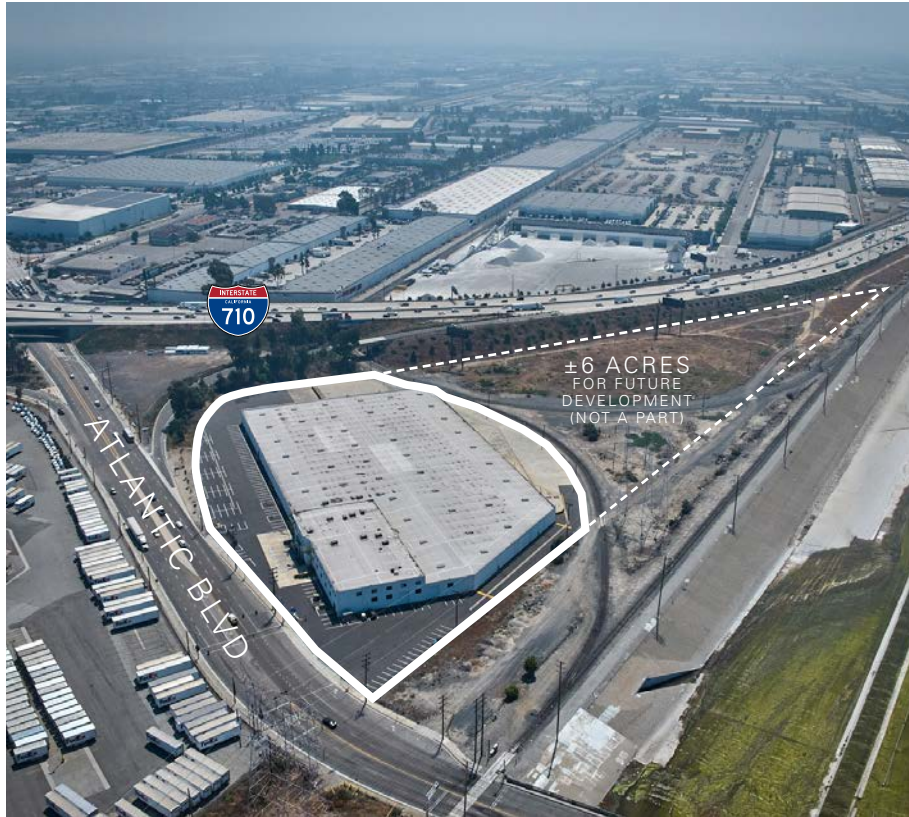
